Project Description:

These projects will include, but are not limited to, services for environmental engineering design, regulatory permitting and remediation services, specifically, the remediation of groundwater contaminants. The goal is to reduce groundwater contaminant concentrations to less than the Florida Department of Environmental Protection's natural attenuation default concentrations within a specified timeframe.

Detailed Description:

Groundwater contaminants that will need to be remediated include 1,4-Dioxane, Trichloroethene, Cis-1,2-Dichloroethene, 1,1-Dichloroethene, Vinyl Chloride, 1,1,1-Trichloroethane, 1,2-Dichloroethane, 1,1-Dichloroethane, Chloroethane, Toluene, 3-Methylphenol and 4-Methylphenol. A more detailed scope of services will be included in the formal request for qualifications.
