Winners may not substitute or transfer the prize and the prize is not redeemable for cash.

Contest period begins on Monday, September 14, 2015 at 3:00 p.m. ET and concludes on Thursday, September 24, 2015 at 12:00 p.m. ET. Any entries received prior to Monday, September 14, 2015 at 3:00 p.m. ET or after Thursday, September 24, 2015 at 12:00 p.m. ET will not be accepted or entered into the contest.

All entries become the property of Hillsborough County Aviation Authority/Tampa International Airport and may be used for promotional purposes.

## Eligibility:

No purchase necessary to enter. Contest is void where prohibited or restricted by law.

One entry per person will be accepted for the contest and contestants must select one social media account for their entry if the contestant has multiple social media accounts.
