Take the blue Earhart elevators to the 3<sup>rd</sup> floor of the Main Terminal. The conference room is between Airside A and the Earhart elevators. The Authority Boardroom is located on the 3<sup>rd</sup> floor of the Main Terminal. Go down the hallway to the left of the blue Earhart elevators. The Boardroom is on the left.
