2. Background

On September 8, 2022, the Authority entered into a Contract for State Legislative Services with GrayRobinson, P.A.

On May 2, 2024, the Board approved the first, one-year renewal option.

On August 13, 2025, the Board approved the second, one-year renewal option.

The Contract currently expires on October 3, 2026.

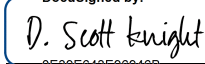
Article IV, TERM, of the Contract states as follows:

"The Term of this Contract commenced on October 4, 2022 and will continue through October 3, 2024 unless terminated earlier as provided herein. This Contract may be renewed at the same terms and conditions hereunder for three (3), one (1) year periods at the discretion of the Board. Such renewal will be effective by issuance of a written letter to Company by CEO. If all such renewals are exercised, this Contract will have a termination date of October 3, 2027."

3. Recommendation

The Vice President of Procurement recommends the Board authorize the third and final, one-year renewal option at the same terms and conditions for the renewal period of October 4, 2026 through October 3, 2027.

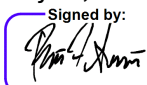

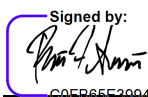
