AMENDMENT NO. 3

TO

PART 1 CONTRACT FOR DESIGN-BUILD SERVICES

This AMENDMENT No. 3 is to the Contract for design-build services which was entered into the 6th day of December, 2018 by and between the Hillsborough County Aviation Authority, a public body corporate under the laws of the State of Florida, hereinafter referred to as the "Owner", and The Middlesex Corporation, a Massachusetts Corporation, authorized to do business in the State of Florida, hereinafter referred to as the "Design-Builder". With the execution of Amendment No. 3, the Owner and the Design-Builder, for the consideration stated herein, and other good and valuable consideration, hereto agree to change provisions of the aforementioned Contract as follows:

1. ARTICLE 1 – DESIGN-BUILDER

Delete Paragraph 1.2.1 in its entirety and replace with the following:

1.2.1 The services that the Design-Builder will provide to the Owner under this Contract will be as follows, and in general accordance with the Owner's Request for Qualifications dated June 6, 2018, entitled "Request for Qualifications for Air Cargo Expansion at Tampa International Airport", the Design-Builder's fee and scope proposal dated November 20, 2018, entitled "Part 1 Agreement Proposal-Rev 2, Air Cargo Expansion Project No. 8240 19: UPS Air Cargo Site," and the Design-Builder's fee and scope proposal for Amendment No. 1 dated July 23, 2019, entitled "UPS Air Cargo Expansion Work Order 19-01c Design Of Dazzo Pump Station Relocation, Hydrant Fueling, and Dual Taxilane Addition (Airfield) Tampa International Airport," and the Design-Builder's fee and scope proposal for Amendment No. 2 dated January 13, 2020, entitled "UPS Air Cargo Expansion – Taxiway Echo-1 (Formerly TW U) Reconstruction at Tampa International Airport," which are incorporated by reference herein, and the Design-Builder's fee and scope proposal dated December 15, 2021, entitled "8240 19 Air Cargo Expansion Contract Amendment 3," which is attached hereto as Attachment No. 1 and incorporated by reference herein. In the event of any conflicts between this Contract and any other documents, the precedence in resolving such conflicts will be as follows:

2. ARTICLE 9 – BASIS OF COMPENSATION

Delete Paragraph 9.0 in its entirety and replace with the following:

9.0 The Owner will compensate the Design-Builder for services rendered under this Contract, as described in Attachment 1.

The amount for the performance of Basic Services required under this Contract and costs identified as reimbursable expenses will be in a not to exceed amount of Four Million Six Hundred Twenty Five Thousand Six Hundred Fifty Four and No One Hundredths Dollars (\$4,625,654.00), which includes all fees for subconsultants.

3. ARTICLE 19 – DISADVANTAGED BUSINESS ENTERPRISE (DBE) ASSURANCES

Delete Paragraph 19.4 in its entirety and replace with the following:

- 19.4 DBE Goals. In compliance with the Owner's DBE policy, the Design-Builder's minimum DBE commitment is established as the sum total of the verified Letter(s) of Intent submitted with their response. The goal stated below is the sum total of the certified DBE's listed in the Design-Builder's Fee and Scope Proposal which is attached hereto as Attachment 1 and which will be enforceable under the terms of this Contract. The Design-Builder will demonstrate that they will subcontract to certified DBEs certified by the Florida Unified Certification Program (FLUCP) at least 8.7% of the dollar amount of the design fees earned under this Contract, or clearly demonstrate in a manner acceptable to the Owner its good faith efforts to obtain certified DBE subcontractors.
- 4. All other consistent terms remain in full force and effect and are hereby ratified and confirmed.
- 5. The Contract, as modified by Amendment No. 1 and Amendment No. 2, represents the entire understanding between the parties on the issues contained in the Contract, either written or oral, and may be amended only by written instrument signed by both parties.

INTRODUCTION

The Middlesex Corporation (TMC) Design Build Team was awarded a contract with the Authority at the HCAA Board Meeting on December 6, 2018, for the Air Cargo Expansion Project (HCAA No. 8240 19). This project was issued work orders 19-01 through 19-01D for site development and airfield scope and 19-02 for the UPS building scope for Part 1 Design Services. Part 1 design services were nearly complete in June of 2020 when the project was deferred due to the COVID-19 pandemic. HCAA directed the TMC Team to complete certain tasks, stop design work, and provide all design data to the Authority. A deactivation meeting was held on May 28, 2020, to provide a status of design related elements and complete all action items prior to middle of June 2020. The Authority has engaged the tenant, UPS, to revalidate the project and update project design criteria. The Authority has requested design services to redesign, permit, and redevelop the GMP. The Authority issued Work Order 19-01E on October 19, 2021, that included the following tasks:

- Task 11 Completion of the Design for Taxiway E-1
- Task 12 General On-Demand Project Reactivation Support Services
- Task 13 Meetings and Meeting Materials
- Task 14 Conceptual Cost Estimate Support
- Task 15 Schedule Development Support

Work Order 19-01E included a net credit of \$308,651.05 for unbilled funds in WO 19-01 Series Basic Services. This credit results in a remaining balance of \$308,651.05 in Middlesex's Current Contract Amount of \$4,089,132.00.

The Authority also issued Work Order 19-01F on December 8, 2021, that included the following tasks:

- Task 16 100% Redesign
- Task 17 Final Redesign

Also of note, current market conditions reveal an increase in wages and burdens of 10 - 20% compared to the second quarter of 2020. In addition, material costs and lead times are extremely volatile due to supply chain issues and demand while equipment costs have risen due to demand and the increase in fuel cost. These increased cost factors are reflected in this work order and will be included in future work orders and cost estimates.





WORK ORDER DESCRIPTION

The TMC Team is currently progressing through changes identified by UPS and HCAA to the final bid documents completed in the spring of 2020. The purpose of this work order is to complete the Part 1 services including the following new tasks:

- Task 18 Permitting
- Task 19 –GMP Redevelopment

This task and work order is anticipated to start in February 2022 and complete with the award of the Part 2 Agreement which will include two GMPs. The first GMP will be include the Pre-Engineered Metal Building (PEMB) which is scheduled for HCAA Board Approval in March 2022. The second GMP will include the balance of the project scope and is scheduled for HCAA Board Approval in June 2022. Our preliminary schedule shows the project will need to be bid with the 100% Redesign documents to meet the Authority's goal of building occupancy by March 2024, which will be part of the Part 2 Contract. The same set of documents will also be utilized to start the Permitting process. A brief schedule of services for this task order is included later in this document.

1.0 TASK 18 - PERMITTING

The scope of this Task is to update SWFWMD permit and DEP permits, if required and to provide permitting through the City of Tampa (COT) that was initially started in 2020 but cancelled prior to review by the COT. It is anticipated that the project will submit for 3 building permits, utility permits, and updates to SWFWMD and DEP permits. This task includes but is not limited to the following:

- Attend regular meetings with Authority project staff to review design status, interim cost estimates, discuss status of project deliverables and review procurement and subcontractor solicitation process. Middlesex will prepare and issue all meeting agenda and minutes for review by the Authority.
- Conduct daily meetings with AECOM and within the DB Team to review subcontractor questions; plan review and comment resolution; stakeholder and utility coordination; and discuss other technical and administrative items.
- Ensure participation by DBE subcontractors and monitor compliance with project goals.
- Finalize budget projections to support creation of the Part 2 GMP for ultimate approval by the Authority, and incorporation into the Part 2 contract.
- Update the P6 baseline schedule based on project progress and 100% and Final Redesign.
- Issue site safety and quality requirements to subcontractors based on approved Site Specific Safety Plan and Construction Quality Management Plan.
- Develop a project procurement plan and implement approved procedure that ensures transparency in the submission and comparison of bids for work items proposed to be self-performed by Middlesex.
- Submit bid proposals, and review with the Authority, for scopes of work proposed to be self-performed by Middlesex. As with all bid packages, we will strive to submit pricing from three responsible bidders.
- Review and rank final bid proposals submitted by prequalified subcontractors.
- Continue outreach and field coordination with local utilities, stakeholders and adjacent developers, as well as TPA airside staff, in advance of commencement of construction activities.
- Day to day administrative support of design, estimating and preconstruction activities; including, document control, invoicing, purchasing, and submission of contract-mandated deliverables.

INTRODUCTION

The Middlesex Corporation (TMC) Design Build Team was awarded a contract with the Authority at the HCAA Board Meeting on December 6, 2018, for the Air Cargo Expansion Project (HCAA No. 8240 19). This project was issued work orders 19-01 through 19-01D for site development and airfield scope and 19-02 for the UPS building scope for Part 1 Design Services. Part 1 design services were nearly complete in June of 2020 when the project was deferred due to the COVID-19 pandemic. HCAA directed the TMC Team to complete certain tasks, stop design work, and provide all design data to the Authority. A deactivation meeting was held on May 28, 2020, to provide a status of design related elements and complete all action items prior to middle of June 2020. The Authority has engaged the tenant, UPS, to revalidate the project and update the project design criteria. The Authority has requested design services to redesign, permit, and redevelop the GMP. The Authority issued Work Order 19-01E on October 19, 2021, that included the following tasks:

- Task 11 Completion of the Design for Taxiway E-1
- Task 12 General On-Demand Project Reactivation Support Services
- Task 13 Meetings and Meeting Materials
- Task 14 Conceptual Cost Estimate Support
- Task 15 Schedule Development Support

Work Order 19-01E also included a net credit of \$308,651.05 for unbilled funds in WO 19-01 Series Basic Services. This credit results in a remaining balance of \$308,651.05 in Middlesex's Current Contract Amount of \$4,089,132.00.

Also of note, current market conditions reveal an increase in wages and burdens of 10 - 20% compared to the second quarter of 2020. In addition, material costs and lead times are extremely volatile due to supply chain issues and demand while equipment costs have risen due to demand and the increase in fuel cost. These increased cost factors are reflected in this work order and will be included in future work orders and cost estimates.





WORK ORDER DESCRIPTION

The TMC Team is currently progressing through changes identified by UPS and HCAA to the final bid documents completed in the spring of 2020. The purpose of this work order is to modify Work Order 19-02 with updated design criteria provided by the Authority and UPS and will run concurrent with Work Order 19-01G. The purpose of this work order is to complete the Part 1 design services including the following new task for Work Order 19-02B:

- Task 3 Permitting and GMP ReDevelopment for the building and site civil elements of the UPS Tenant Facilities
 - o Task 3.1 Permitting
 - o Task 3.2 GMP Redevelopment

This task and work order is anticipated to start in February 2022 and complete with the award of the Part 2 Agreement which will include two GMPs. The first GMP will be include the Pre-Engineered Metal Building (PEMB) which is scheduled for HCAA Board Approval in March 2022. The second GMP will include the balance of the project scope and is scheduled for HCAA Board Approval in June 2022. Our preliminary schedule shows the project will need to be bid with the 100% Redesign documents to meet the Authority's goal of building occupancy by March 2024, which will be part of the Part 2 Contract. The same set of documents will also be utilized to start the Permitting process. A brief schedule of services for this task order is included later in this document.
