# HILLSBOROUGH COUNTY AVIATION AUTHORITY AMENDMENT NO. 1 TO THE TECHNICAL SUPPORT SERVICES CONTRACT FOR EASE CONTRACT

THIS AMENDMENT NO. 1 to the Technical Support Services Contract for EASE (Contract) dated March 1, 2018, by and between Hillsborough County Aviation Authority, an independent special district under the laws of the State of Florida (Authority), and Amadeus Airport IT Americas, Inc, a Delaware corporation authorized to do business in the State of Florida (Company), is entered into this \_\_\_\_\_ day of December, 2022.

#### I. WITNESSETH

WHEREAS, on March 1, 2018, Authority and Company entered into a Contract for Technical Support Services for EASE; and

WHEREAS, the Parties wish to amend the Contract in order to revise the amounts to be paid under the Contract and exercise the first renewal option in accordance with the terms and conditions of the Contract.

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, the parties do agree that the Contract is amended as follows:

- 1. The above recitals are true and correct and are incorporated herein.
- 2. The Contract is hereby renewed in accordance with Section 3.05 Renewal Options, from March 1, 2023 through February 28, 2025, the Contract final termination date.
- 3. Section 4.01. Payment, Paragraph A. Software Support, Sub-paragraph 1 is deleted in its entirety from the Contract and replaced with:
  - The amount to be paid under this Contract shall not exceed \$2,300,000.
- 4. Except as provided herein, all other terms and conditions of the Contract remain in full force and effect and are hereby ratified and confirmed. The Contract and this Amendment No. 1 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.


