#### HILLSBOROUGH COUNTY AVIATION AUTHORITY AMENDMENT NO. 2 TO CONTRACT FOR SPECIAL LEGAL SERVICES

THIS AMENDMENT NO. 2 to the Contract for Special Legal Services (Contract) dated April 9, 2020, by and between Hillsborough County Aviation Authority, a public body corporate under the laws of the State of Florida (Authority), and Hill, Ward & Henderson, PA (Special Counsel), is entered into this \_\_\_\_ day of March, 2022.

#### WITNESSETH:

**WHEREAS**, on April 9, 2020, Authority and Special Counsel entered into the Contract for Special Counsel to provide certain legal services; and

**WHEREAS**, Authority desires to exercise the one, one-year renewal option, thereby revising the end date of the Contract to April 8, 2023; and

**WHEREAS**, Special Counsel has agreed to continue to provide the legal services to Authority in accordance with the terms and conditions of the Contract.

**NOW, THEREFORE**, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, the parties do agree that the Contract is amended as follows:

- 1. Upon approval and execution of this Amendment No. 2 by both Authority and Special Counsel, the end date of the Contract will be revised to April 8, 2023.
- 2. Article 3, <u>Compensation</u>, Section 3.2, <u>Not-to-Exceed</u>, is deleted in its entirety and replace with the following:

The amounts to be paid under this Contract shall not exceed \$650,000 without prior approval of the Authority. However, Special Counsel must notify General Counsel when the total amount paid under this Contract is set to exceed \$600,000. Special Counsel shall not perform any additional services until General Counsel approves performance of services in excess of \$600,000.

3. Except as provided herein, all other terms and conditions of the Contract remain in full force and effect and are hereby ratified and confirmed. The Contract, Amendment No. 1 and this Amendment No. 2 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.
