## AMENDMENT NO. 1

TO

## CONTRACT FOR DESIGN PROFESSIONAL SERVICES

This AMENDMENT No. 1 is to the Contract for Continuing Structural Consulting Services which was entered into the 6<sup>th</sup> day of August, 2020 by and between the Hillsborough County Aviation Authority, a public body corporate under the laws of the State of Florida, hereinafter referred to as the "Owner", and Walker Parking Consultants/Engineers, Inc. d/b/a Walker Consultants, a Michigan Corporation, authorized to do business in the State of Florida, hereinafter referred to as the "Consultant". With the execution of Amendment No. 1, the Owner and the Consultant, for the consideration stated herein, and other good and valuable consideration, hereto agree to change provisions of the aforementioned Contract as follows:

## 1. ARTICLE 5 – PAYMENTS TO THE DESIGN PROFESSIONAL

Delete Paragraph 5.1 in its entirety and replace with the following:

- 5.1 The amount for the performance of basic services required under this Contract, and identified as direct and reimbursable expenses, will be in a not-to-exceed amount of Five Million Seven Hundred Thousand and No One Hundredth Dollars (\$5,700,000), which includes all fees for subconsultants.
- 2. All other consistent terms remain in full force and effect and are hereby ratified and confirmed.
- 3. The Contract, as modified by this Amendment No. 1, represents the entire understanding between the parties on the issues contained in the Contract, either written or oral, and may be amended only by written instrument signed by both parties.
