AMENDMENT NO. 2 TO CONTRACT FOR SPECIAL LEGAL SERVICES

WHEREAS, Special Counsel has agreed to continue to provide the services to Authority in accordance with the terms and conditions of the Contract.

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, the parties do agree that the Contract is amended as follows:

1. Delete Article 3, <u>Compensation</u>, Section 3.2, <u>Not-to-Exceed</u>, in its entirety and replace with the following:

The amounts to be paid under this Contract shall not exceed \$250,000.

2. Except as provided herein, all other terms and conditions of the Contract remain in full force and effect and are hereby ratified and confirmed. The Contract, Amendment No. 1 and this Amendment No. 2 represent the entire understanding between the parties on the issues contained herein, either written or oral, and may only be amended by written instrument signed by both parties.
