





Airport Pattern North Flow






2023 Data 2018 Data

Airport Pattern South Flow



Airport Flow

- Airport Flow (June and July Combined):
 - 61.7% South Flow
 - 38.3% North Flow
- Same Period 2022:
 - 62.5% South Flow
 - 37.5% North Flow




Wind Direction Dictates Airport Flow

- Operational Period
 - January 1st to July 5th
 - Non-Commercial Flights Included

Taxiway E Closure – Additional Traffic on 10-28

- Taxiway E, the Airport's primary east airfield taxiway which runs north-south is partially closed
- This closure drives additional runway crossings for aircraft departing to the south
- This closure has resulted in increased corporate jet operations on/off runway 10-28
- After the upcoming 31-day closure of Runway 1R/19L, Taxiway E will reopen full length





Irregular Operations

- June 3rd Disabled aircraft
 - Tire debris
- Runway 10 Usage (2 hours)
 - 37 Arrivals
 - 17 Departures





Irregular Operations Continued

- July 8th, 2023 Runway 1L/19R repair
 - Emergency Runway Repair
- Runway 19L Usage (3 hours)
 - 22 Commercial Departures
