## <u>Directions to RCC Conference Room:</u>

RCC Conference room is located on the third floor of the Rental Car Center Building. Upon exiting the SkyConnect train, walk towards the Remote Baggage drop off area. The door to the conference room is immediately across the main hall on the left of the Remote Baggage drop off area.

<u>Parking</u>: Parking for the public to access the Rental Car Center is in the Economy Parking Garage. Respondent's will following signs to Economy Parking Garage. Once parked in the Economy Parking Garage, Respondent's will access the SkyConnect train by taking the elevators located on Level 1 of the Economy Parking Garage. Respondent's will then take the SkyConnect train to the Rental Car Center and exit the SkyConnect train. Turn right and follow the signs to SkyCenter.

## Directions to SC4-C3 Conference Room:

Conference Room SC4-C3 - SkyCenter is located on the fourth floor of the SkyCenter Office Building. Access to Conference Room SC4-C3 is through the SkyCenter Atrium by going to the fourth floor of the Atrium and then going to the north side of the Atrium where the Atrium meets the SkyCenter Office Building. Conference Room SC4-C3 is located to the right of the Authority receptionist counter.

<u>Parking</u>: Parking for the public to access the SkyCenter Office Building is in the Economy Parking Garage. Respondent will following signs to Economy Parking Garage. Once parked in the Economy Parking Garage, Respondent will access the SkyConnect train by taking the elevators located on Level 1 of the Economy Parking Garage. Respondent will then take the SkyConnect train to the Rental Car Center and exit the SkyConnect train. Turn right and follow the signs to SkyCenter.
